







Doctoral Fellowship on Social Economy & Common Goods Management

The Centre for European Research in Microfinance (CERMi), Solvay Brussels School of Economics and Management, Université Libre de Bruxelles (ULB) and the BIOGOV unit of the Centre for the Philosophy of Law (Université Catholique de Louvain (UCL) are offering a full time 2 + 2 –year research fellowship on "social economy and the commons".

The grant could start as early as September 2017 and will aim at a Ph.D. in Economics and Management (Management track) at ULB. The objective of the PhD research is to understand the potential of social economy in the management of commons and the specific methodologies in their collective management.

Created in 2007, CERMi draws together European researchers in microfinance and other types of social finance. Currently, it gathers 10 doctoral students and a wide international network of more than 30 research associates. The Centre for Philosophy of Law is an interdisciplinary centre focusing on social and political theory for deepening democratic governance of social and ecological issues.

This fellowship is part of the interdisciplinary "Actions de Recherche Concertée" (or ARC) titled "Locals dealing with Developmental Incomes" which addresses financial amounts drawn from the exploitation of natural resources and allocated to riverine communities. The doctoral fellow will work under the supervision of Marek Hudon, Professor at Université libre de Bruxelles (ULB) and Tom De Dedeurwaerdere, Professor at the Université Catholique de Louvain (UCL) and will be based in Brussels, at the Solvay Brussels School of Economics and Management (ULB).
