The Warren Samuels Prize is awarded by the **Association for Social Economics** to a paper, presented at the ASSA meetings, that best exemplifies scholarly work that is of high quality, is important to the project of social economics, and has broad appeal across disciplines.

**Niels Hermes and colleagues Reggy Hooghiemstra and Jim Emanuels** received the **2015 runner-up best paper award of** *Corporate Governance: An International Review* (CGIR, volume 23) for their paper "National Culture and Internal Control Disclosures: A Cross-country Analysis" (23, 4, pp. 357–377). The nomination criteria included the following three standards:

1) The research question and findings must be highly relevant to practitioners and/or policymakers

2) The research study must be both theoretically and methodologically rigorous

3) The research publication must be published in 2015 in CGIR.

The award is sponsored by the Geneen Institute: \$7,500 for the best paper award and \$2,500 for the runner-up paper award. Award committee member Cynthia Clark made this nominating comment on the paper: "Interesting focus on culture and its effect on corporate disclosure. The cross boarder tension between the US (required) and the rest of the world (voluntary) is a nice setting for incentives to disclose risk-related information. Policy implications are clear and meaningful (conformity of disclosures is counterproductive)".
